# 2. Describe in detail how the pandemic has affected your organization.

My office continues to fight for the safety of our community in the courtroom, in spite of the funding challenges our circuit faces. We were able to reduce the backlog of cases by nearly 10 percent before March of 2020 when the court shutdowns began as the result of the COVID pandemic. But coming out of the pandemic shutdowns and the explosion of our case backlogs, my office is desperate for resources and manpower to address these massive caseloads.

The past two years has been a very difficult road for our nation, and our citizens locally have not been immune from the fallout of the COVID pandemic and the resulting government response. We believe that this request is right in line with the purpose of the federal ARP funding, to address a core function of government (the criminal justice system) that has been severely impacted by the pandemic.

#### 3. How will any funding awarded be utilized?

We are requesting the County of Laurens to set aside funding for a 3-year "grant" prosecutor in our office who would be solely dedicated to cases in Laurens County. This prosecutor would work only on violent and serious cases. The costs including salary (\$70K/year) and fringe benefits for an experienced prosecutor in this position Is \$93,870 per year, for a total over three years of \$281,610. The remaining \$18,390 will be used to cover trial expenses for cases in Laurens County.

## **Program Purpose**

The American Rescue Plan Act (ARPA) was signed into law by President Biden on March 11, 2021, and provides direct relief to cities, towns and villages in the United States through the Coronavirus State and Local Fiscal Recovery Funds (CSLFRF). The U.S. Department of the Treasury is responsible for overseeing this program. CSLFRF provides that states and other governments may spend these funds to "respond to the pandemic and its negative economic impacts, including assistance to ... nonprofits, or aid to impacted industries such as tourism, travel, and hospitality." Laurens County will be awarding grants to non-profits or similar organizations from the CSLFRF to help address critical financial needs of those organizations. For profit-businesses and individuals are not eligible for these County grants.
