Chartered in 1967, the Clinton Family YMCA has been serving the Clinton community and greater Laurens county for 55 years. Having served from its present location since 1973, the YMCA has the unique responsibility as the sole recreational provider for the greater City of Clinton and its citizens. The programs of the Clinton YMCA bridge the gaps in our community drawing together young people and senior citizens, working parents and singles, and people of all races and cultures in wholesome physical activities.

The Clinton Family YMCA is planning today to meet the needs of our community's future families, children, teens, adults and seniors with such activities through our programs at the YMCA. The reasons are quite simple: we believe in the wholesome, character-building and people-centered programs of the YMCA. As always, our efforts continue to be guided by the mission of the YMCA: "To put Christian principles into practice through programs that build a healthy body, mind and spirit for all."

2. Describe in detail how the pandemic has affected your organization.

The covid pandemic was devastating to YMCA's all over the state of South Carolina. The Clinton Family YMCA was closed and programs suspended, our revenue dropped by more than 40% and membership close to 60%, but fixed costs such as utilities, equipment leases, wages, employee benifits, and occupancy costs remained unchanged. We were able to continue to pay staff and avoid layoffs and continue to deliver programming through social distanced child care and creative wellness programs with altered spaces. We serve a very vulnerable population (very old, very young, low-income families). The mental health, socialization/social benfits, and overall wellness of the people we serve were compromised. We had to pivot. And our community was tested in ways we have never seen before and the Clinton Family YMCA was called into action. Together, we adapted to the challenges of the pandemic and learned new ways to provide critical programs that kept our communities engaged, healthy and safe, while overcoming loss of revenue and infrastructure challenges.

3. How will any funding awarded be utilized?

The funds provided by the American Rescue Plan Act of 2021 would specifically be used to upgrade our facilities that support our pool. The Clinton Family YMCA has the only indoor pool in Laurens County and it is used by all of our citizens for recreation, health and wellness. Specifically, the funds would be used to make needed upgrades to plumbing, electrical, mechanical, and the Dectron unit that is due to be replaced. The project would be two phases. The first phase would be the Dectron unit, which would cost approximately \$500,000. The second phase would go towards the wet areas that support the pool. Consisting of our locker rooms, bathrooms, showers, sauna, and whirlpool. Needed upgrades to facilities that are aging and need repair. The total cost of phase two would be approximately \$500,000.

The operation and maintenance of our pool facility places a tremendous financial burden on the YMCA's budget, and coupled with the cost of daily operations and maintenance, it is a financial issue of concern.

Through our scholarship program, no one is denied membership or program participation because of their inability to pay. Individuals and families can apply for assistance, which utilizes a sliding scale based on income to determine level of assistance to be provided. The program pays part of and in some cases all of the fees associated with YMCA programs and membership. Our current 2022 budget provides in excess of \$150,000 in scholarship support and is anticipated to benefit over 4,740 individuals, which includes over 38% of its membership by providing them access to quality programs, services, and facilities. CSLFRF provides that states and other governments may spend these funds to "respond to the pandemic and its negative economic impacts, including assistance to ... nonprofits, or aid to impacted industries such as tourism, travel, and hospitality." Laurens County will be awarding grants to non-profits or similar organizations from the CSLFRF to help address critical financial needs of those organizations. For profit-businesses and individuals are not eligible for these County grants.

This letter is in response to your request for a copy of your organization's determination letter. This letter will take the place of the copy you requested.

Our records indicate that a determination letter issued in August 1973 granted your organization exemption from federal income tax under section 501(c)(3) of the Internal Revenue Code. That letter is still in effect.

Based on information subsequently submitted, we classified your organization as one that is not a private foundation within the meaning of section 509(a) of the Code because it is an organization described in section 509(a)(2).

This classification was based on the assumption that your organization's operations would continue as stated in the application. If your organization's sources of support, or its character, method of operations, or purposes have changed, please let us know so we can consider the effect of the change on the exempt status and foundation status of your organization.

Your organization is required to file Form 990, Return of Organization Exempt from Income Tax, only if its gross receipts each year are normally more than \$25,000. If a return is required, it must be filed by the 15th day of the fifth month after the end of the organization's annual accounting period. The law imposes a penalty of \$20 a day, up to a maximum of \$10,000, when a return is filed late, unless there is reasonable cause for the delay.

All exempt organizations (unless specifically excluded) are liable for taxes under the Federal Insurance Contributions Act (social security taxes) on remuneration of \$100 or more paid to each employee during a calendar year. Your organization is not liable for the tax imposed under the Federal Unemployment Tax Act (FUTA).

Organizations that are not private foundations are not subject to the excise taxes under Chapter 42 of the Code. However, these organizations are not automatically exempt from other federal excise taxes.

Donors may deduct contributions to your organization as provided in section 170 of the Code. Bequests, legacies, devises, transfers, or gifts to your organization or for its use are deductible for federal estate and gift tax purposes if they meet the applicable provisions of sections 2055, 2106, and 2522 of the Code.

Your organization is not required to file federal income tax returns unless it is subject to the tax on unrelated business income under section 511 of the Code. If your organization is subject to this tax, it must file an income tax return on the Form 990-T, Exempt Organization Business Income Tax Return. In this letter, we are not determining whether any of your organization's present or proposed activities are unrelated trade or business as defined in section 513 of the Code.

The law requires you to make your organization's annual return available for public inspection without charge for three years after the due date of the return. If your organization had a copy of its application for recognition of exemption on July 15, 1987, it is also required to make available for public inspection a copy of the exemption application, any supporting documents and the exemption letter to any individual who requests such documents in person or in writing. You can charge only a reasonable fee for reproduction and actual postage costs for the copied materials. The law does not require you to provide copies of public inspection documents that are widely available, such as by posting them on the Internet (World Wide Web). You may be liable for a penalty of \$20 a day for each day you do not make these documents available for public inspection (up to a maximum of \$10,000 in the case of an annual return).

Because this letter could help resolve any questions about your organization's exempt status and foundation status, you should keep it with the organization's permanent records.
