Fountain Inn Kid Enrichment Center (FIKE) is a nonprofit that provides free serves to lower income families in Fountain Inn. We have lost funding due to Covid-19. We had to shut down for four months when the pandemic first came out with fear of exposure, we had many of our students participate in virtual classes when brick and mortar was offered back again for the next school year. We decided to open back up and serve both sets of students. We lost staff, some of our students, and the ability to do any type of fundraising. With the rising and declining and variants, everything is harder on folks in our community. Individual giving has decreased as well as local businesses that once supported us has found their budgets slashed since no one was going out and spending. Even large corporations sent their employees to work from home. We lost the focus of giving back to the community unless it was pandemic focused. Therefore, our budget has been hit hard and we are struggling to serve the obvious need that is here in Fountain Inn.

1. Briefly state the history and purpose of your organization.

Fountain Inn Kid Enrichment Center (FIKE) began in 2012 with a simple purpose: to come alongside families in the Fountain Inn community who are struggling, and serve their children with a safe, free after school environment and a trustworthy mentor. We have worked hard to provide our students with opportunities to learn, grow and mature, while easing the burden on their parents and guardians. Fountain Inn Kid Enrichment Center (FIKE) is a non-profit organization with a mission to ENCOURAGE, **EDUCATE ENRICH** children need. After school FIKE in children find: A safe and caring place where they can grow educationally, physically, emotionally, and spiritually. We offer a wide variety of activities specifically designed to instill confidence, foster leadership, strengthen character and cultivate a passion for knowing God and walking with Him!

FIKE After school is a tutoring and homework program that focuses on meeting children's educational needs as identified by their teachers. FIKE was first designed to help children with schoolwork for better understanding and improved academic performance.

Children in FIKE have excelled in their schoolwork which raises their self-esteem and facilitates them in meeting their educational requirements — thus creating an enthusiastic attitude toward school and learning.

We decided to open back up and serve both sets of students. We lost staff some of our students, volunteers and the ability to do any type of fundraising. With the rising and declining and variants, everything is harder on folks in our community. Individual giving has decreased as well as local businesses that once supported us has found their budgets slashed since there was a decline in going out and having to find employees. Even large corporations sent their employees to work from home. We lost the focus of giving back to the community unless it was pandemic related Therefore, our budget has been hit hard and we are struggling to serve the obvious need that is here in Fountain Inn.

Fountain Inn Kid Enrichment Center (FIKE) will be utilizing a majority of the awarded funds to growth. Already since the beginning of the pandemic we started back with only 25 students participating in our program. We grew to 31 students by the end of the 20/21 school year. This school year we are 42 students and have more students on a waiting list. We anticipate getting back up to our pre pandemic numbers for next year as long as we continue moving forward with Covid-19. FIKE could see numbers in the 50s and 60s which means more staffing and supplies. We will also use our marketing funds to promote our mentoring program that we would like to restart. There is a light at the end of the tunnel FIKE is looking for our community to come along beside us as we try to reach it.

Fountain Inn Kid Enrichment Center (FIKE) since 2019, has been awarded a United Way of Greenville County grant for 2020 and 2021. We have received funding from the Greenville Health Authority. TJ Maxx in Simpsonville nominated us as receiving funding from the TJ Maxx Foundation. FIKE was chosen as a recipient for Hillcrest Spirit week.
Amanda Beattie started as Executive Director with Fountain Inn Kids Enrichment Center in January 2019. She earned her Bachelor of Science from East Tennessee State University in 2004. Building on more than 16 + years of non-profit management experience, Amanda works diligently to grow FIKE from one site serving 50 children to multiple sites across Fountain Inn and Laurens County. Her dedication to serve children and families in need is a great fit for FIKE.
We run a ratio of 15 kids per tutor for a smaller class size that allows for more one on one for assistance in tutoring and leadership classes. Tutors are 18 years or older. Each staff member and volunteer must submit for a through background check and Covid protocols. Two weeks training for tutors as well as two weeks of shadowing before taking on the responsibility of a FIKE team.

Fountain Inn Kid Enrichment Center (FIKE) consistently is looking for other programs and organizations to partner with to serve our community. We have partnerships with Center for Community Services that receives snack donations and they fill a buggy of snacks for us. The Lord Table Feeds is a nonprofit who feeds homeless families in Fountain Inn. We work together and they dinner to our children every Wednesday. Many of our students come from food insecure families. That is why we feed them dinner to make sure that they have something till school the next day. We partner with Fountain Inn Elementary; the teachers are the one who completes referral forms for underserved students whose families cannot afford after school care. Capstone Church provides our meeting space and offers FIKE accounting services. Rotary Club of Fountain Inn provides school supplies for Back to School and we partner together for the Fountain Inn Christmas Parade.

6. What is your plan for continuing your program(s) in the future, including funding sources?

America After 3PM revealed that 98,111 children (13%) in South Carolina participate in an afterschool program, yet 330,964 children (51%) would be enrolled in a program if one were available to them. 18% of children are unsupervised after school in 2014 for an average of 9.39 hours per week. Economic conditions are forcing more single parents into the workplace at a time when children need adult supervision. These children face a growing number of problems such as abuse, delinquency, depression and suicide, drug and alcohol abuse, emotional and behavioral problems, learning difficulties, school attendance problems, domestic violence, pregnancy. Many children experience stressful situations without ready access to adult support. It is estimated that as many as 10 million American children care for themselves before or after school. Many latchkey kids begin their self-care responsibilities at about 8 years of age. Studies show that nearly 30 percent of all children younger than 14 years of age care for themselves or are cared for by older siblings during non-school hours. FIKE longs for the opportunity to grow. To be able to reach more students and their families. FIKE sees the need, not only in their one program, there are many more that FIKE could serve if given the opportunity. FIKE desires to change the world on kid at a time.
