#### GIVE A BRIEF STATEMENT OF NEED FOR AMERICAN RESCUE PLAN ACT (ARPA) FUNDS.

This section is limited to 2900 characters including spaces, which is approximately 400 words. Throughout the past two years, during the Covid pandemic, the Laurens County Chamber of Commerce (The Chamber) has worked hard to pivot in the necessary areas to support Laurens County, as a whole, throughout unprecedented times. As a 501c6 organization, we did not qualify for PPP until the second round of funding, although two of our main sources of income were greatly impacted. Since March 2020, the LCCC has written off eighty-one Chamber members, equaling \$20,287 in lost renewals and during the 2020-21 fiscal year, we were unable to host two of our annual fundraisers and hosted events suffered a decline in participation, causing the Chamber's event income to be \$35,649 under budget. The Chamber's income has been impacted by Covid but the drive to carry out our mission, to serve as the unified voice to promote, strengthen and develop Laurens County by connecting organizations, supporting businesses, and building community has not. We have reallocated funds where needed and some of the programming we would normally host has been on pause. The ARPA funds we are requesting will give the Chamber an opportunity, with the Small Business Empowerment Program, to regain and rebuild our membership, while supporting local business and enhancing quality of life. The Chamber will regain lost revenue, but also position local businesses on a more successful path for sustainability and mitigate financial hardship as a result of the past two years.

#### ORGANIZATIONAL PROFILE AND PROJECT DESCRIPTION

1. Briefly state the history and purpose of your organization.

The Laurens County Chamber of Commerce's (The Chamber) mission is to serve as the unified voice to promote, strengthen and develop Laurens County by connecting organizations, supporting businesses, and building community. Founded in 1978, this organization has grown and developed over the years to be an important organization across the County, working to spearhead many efforts of communication, collaboration, and coordination across municipalities, businesses, and residents. The Chamber acts as the umbrella organization to many initiatives like Leadership Laurens County, The Touchdown Club, Laurens County Future Scholarship, and Keep Laurens County Beautiful, overseeing and hosting many events; networking, business development, roundtable discussions, and educational. The Chamber serves as the Tourism arm of the County, designing and printing the LC Community Guide and managing multiple websites and social media accounts. The Chamber partners, learns, and works regionally to support businesses located in Laurens County, build community pride, and enhance the quality of life within the County. The Chamber is gladly tasked with community wide, impactful initiatives that touches all residents, some directly and some indirectly.

2. Describe in detail how the pandemic has affected your organization.

The Chamber had the ability to pivot work plans to focus in the most important areas for Countywide success. We have hosted multiple roundtables discussions from non-profits to leadership across the County. The Chamber rallied around Small Businesses and encouraged residents to shop small, nonmember businesses included. We understood the small business struggle during these times and chose to work hard to make up for the loss of eighty-one Chamber members, equaling \$20,287, since March 2020. We made "in business" videos, created small business "covid Smart Start" plans and "Covid Recovery" plans for small businesses, and communicated resources directly with the business representatives across the County. The Chamber secured \$50,000 in funding through County Council, offering businesses micro grants and used the information collected through the application process to direct educational opportunities for sustainability. The Chamber is traditionally an event driven organization, which all changed during Covid. During the 2020-21 fiscal year, we were unable to host two of our annual fundraisers and hosted events suffered a decline in participation, causing the Chamber's event income to be \$35,649 under budget. The Chamber team has worked hard to continue to be successful, even during challenging times.

#### 3. How will any funding awarded be utilized?

Small Business in Laurens County have been forced to pivot in many ways to adjust to the impacts of Covid, many are still recovering. As a Chamber, we have put a special focus on promoting, supporting, and helping these businesses over the past couple of years. We have a plan to take this a step further with a Small Business Empowerment Program. This will include focused support to fifty Laurens County businesses through a registration process, participants will receive educational workshops (like technical assistance), one on one consultations with the SCBDC, the opportunity to speak at "The Brew," Small Business networking gatherings, premier Shop local participation, a one time \$500 grant after one year of participation, plus a year membership to the Chamber to help mitigate financial hardship. This initiative will also enhance the Shop Local/Think Local Campaign already active through Marketing and Communications across the County, supporting all businesses.

4. State your organization's ability to continue operations (i.e. current staffing levels, staff qualifications, prior experience, etc.)

The Chamber team is stronger than ever with the right people in the right positions to take everything we do to a new level of expertise. We currently have four full-time employees: President/CEO Amanda Munyan, with over fifteen years of experience in supporting Laurens County growth, as an entrepreneur and work in the non-profit sector, Vice President of Accounting & Operations Marlene Owings, with fifteen years' experience at the Chamber, Communications & Marketing Coordinator Graysen Martin, with a Marketing & Business degree from Lander, and a Beautification Affiliate Coordinator Courtney Stonell. With the right people in place, we need the resources to do the work and help the Small Businesses in our County be as successful as possible, as they continue to recover from the impact of Covid. These businesses employ our residents, build community, and enhance the quality of life across Laurens County.

5. Discuss your organization's relationship with other programs in the community designed to meet the same or similar needs, especially those that provide services/assistance to those most impacted by the pandemic. Describe collaborative partnerships that may result.

The Chamber partners with every municipality, organization, non-profit, and business possible. Main Street Laurens and the City of Laurens, along with Main Street Clinton and the City of Clinton, are very important partners in the support of Small Business in Laurens County. We currently work with all of these groups to plan educational workshops for businesses, assess needs, and share resources and information. We also have great relationships with all media sources across the County and plan to work with them to continue to broadcast the importance of Thinking Local and Shopping Small. The SCSBDC-Greenwood Small Business Development Center is vital in the success of our programing, and we look forward to the opportunities to partner with them on workshops. We have communicated with local financial institutes about small business funding and resources like PPP and we will continue to research all opportunities.

6. What is your plan for continuing your program(s) in the future, including funding sources?

The Small Business Empowerment Program has existed for the past four years through the Chamber and we will continue to offer workshops and resources for our businesses across Laurens County. With a boost in funding, focused on this initiative, we will be able to enhance the offerings and have a strong focus group over a years' time, with added opportunities aimed to help businesses impacted by Covid. We currently have approximately \$5,000 in the budget annually for this work. With a boost in funding around this initiative, we will have the opportunity to learn more for the support of our local businesses, develop more relationships for current and future opportunities, and build up the businesses that have toughed out the times and are still here, trying to recover.
